Intent

The following policy sets out Hurworth House School arrangements for ensuring students have access to a range of providers with the purpose of providing high quality careers education information advice and guidance. The following ensure Hurworth House Schools compliance under section 42B of the Education Act 1997.

Statutory requirements

Schools are required to ensure that there are opportunities for a range of education and training providers to access Students in years 8 – 13. This is for the purpose of informing and advising Students about qualifications and pathways into employment including technical qualifications and Apprenticeships. There is a requirement for Schools to provide this under section 42B of the Education Act 1997,

Student entitlement

All students studying at Hurworth House will be assisted to:

- Explore and understand likes, dislikes, skills and qualities and how these can transfer to a career pathway.
- Find out about different courses available upon progression from Hurworth House and what qualifications are needed to access these courses including but not limited BTEC, A Levels, T Levels, GCSE.
- Explore alternative courses and pathways if entry requirements are not met for chosen course.
- Explore Apprenticeship routes into chosen career pathway.
- Explore training provider routes into chosen career pathway.
- Explore Higher Education opportunities.
- Develop skills needed for working life.
- Record and evaluate CEIAG activities
- Access high quality information, advice and guidance from a range of sources including impartial advice from a level 6 qualified Careers Advisor.
- Make aspirational choices about career pathways.
- Develop employability skills including CV building and interview techniques.
- Access visits and taster sessions at a range of education and training providers.

Access Opportunities

Providers will be welcomed into school to deliver one to one and group sessions to Students. This will run year round and dedicated focus weeks for Further and Higher Education guidance are in place.

Students will also be given access to formal and informal visits to providers and taster session in order for young people to make an informed decision about pathways.

An annual Career Fair takes place at Hurworth House. Providers from Industry, Further Education, Higher Education and Training Providers are present to give young people advice from a range of sources.

Hurworth House also runs the following focus weeks in partnership with providers. All activities are differentiated by key stage with barriers to learning taken into account.

- Employability Week - NCFE Employability qualification
- Labour Market and Vocational Profiling Week
- FE, Sixth Form & Higher Education Week/National Apprenticeship week
- National Apprenticeship week
- STEM week (British Science week)
- Work Experience Week
- Community and Volunteering Week

Facilities

Hurworth House will ensure all providers have access to necessary facilities and equipment including but not limited to; Private meeting rooms, Audio Visual equipment, ICT facilities, Main School Hall.

Site Security

All visitors to the school are approved by Head Teacher. If required DBS details are requested from providers. Any visitor not in possession of a DBS will be accompanied by Hurworth House staff at all times.
